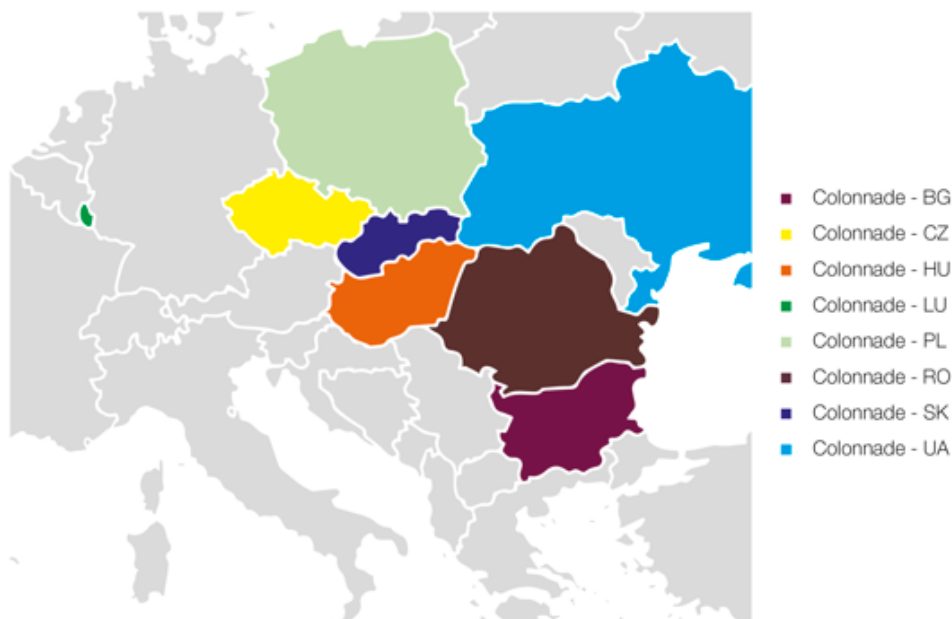

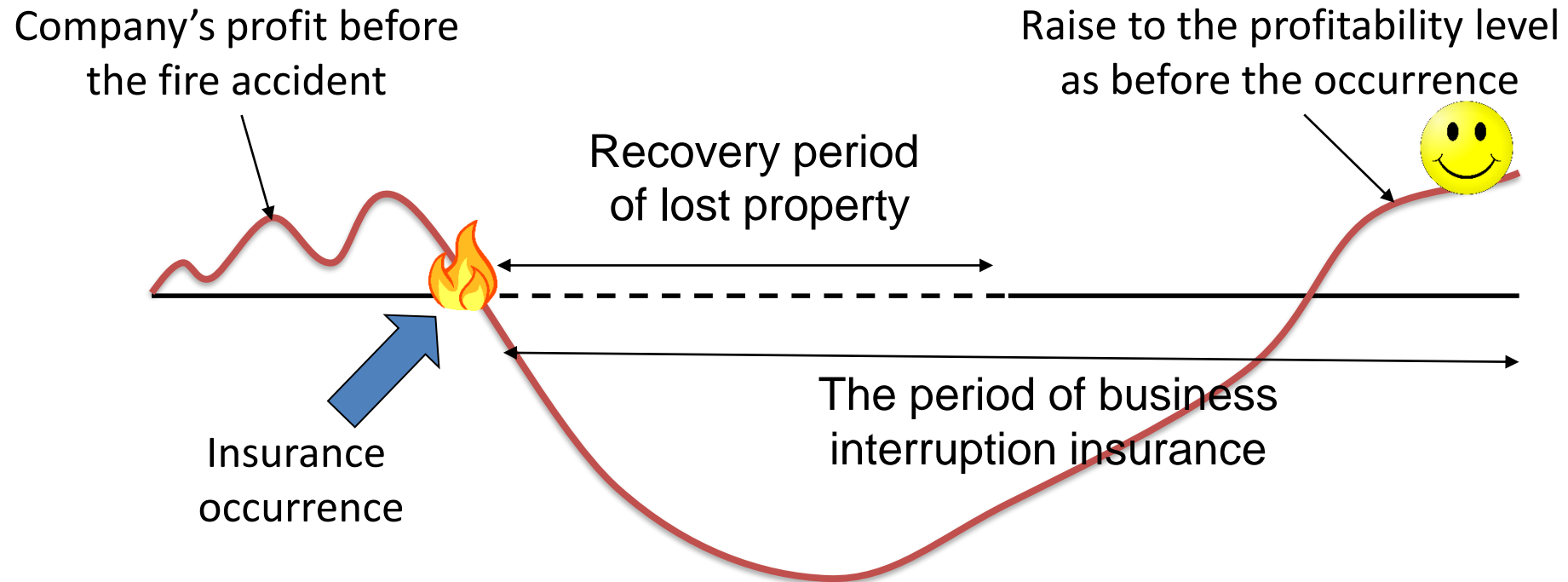
## FIRE ON PHARMACEUTICAL PLANT IN 2017

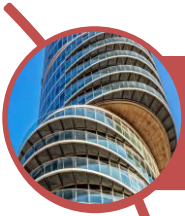
